



PARKS AND RECREATION BOARD MINUTES

I. CALL TO ORDER PRB Chair Corey Hines called the meeting to order at 6:30 pm.

1. Updates from Staff

Kristian updated members on vendor pricing for shade sails, Pavilion and retaining wall for Rogers Farm Park.

The Public Works Department will reach out to the Texas Parks and Wildlife Department for suggestion.
