III. Summary:

According to Section 5.05 of the Texas Tax Code, the taxing unit must vote to place a proposal to adopt the proposed tax rate as an action item on the agenda of a future meeting when a proposed rate exceeds the rollback rate or the effective rate, whichever is lower, and hold two public hearings prior to. At its special called meeting on August 25, 2011, Council approved the placement of an item to adopt a proposed tax rate not to exceed \$.722500 on September 22, 2011 (special session). Furthermore, it scheduled two public hearings on the proposal to occur on September 8 (regular session) and September 15 (special session). The public was notified of both public hearing dates, times and places in the Fort Worth Star Telegram on August 26, 2011.

Taxpayers must have the opportunity to express their views on the revenue increase at each hearing, and the governing body may not adopt the tax rate at either.

City Staff will make a summary presentation prior to council receiving public comments, if any on the FY2011-2012 Proposed Tax Revenue Increase, given the Council Budget Retreat/Workshop conducted on August 13, 2011.

This is a public hearing only. Action will be scheduled during a special called meeting on September 22, 2011. The FY2011-2012 budget and tax rate will be adopted, and the FY2011-2012 budget ratified.
