If you have joined by browser or app, ensure that you enter your name as you would like to be recognized. If attending in person, please submit a "Request to Speak" form before the meeting begins. Speakers should begin by stating their name and address, will be allotted three (3) minutes, should limit their comments to the current item, and should address the Council as a whole, rather than individual Councilmembers or staff.*

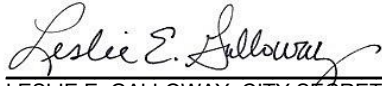
IV. ADJOURNMENT
