B. Christmas Tree Lighting KKB/PRB Hot Chocolate

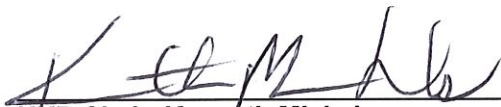
